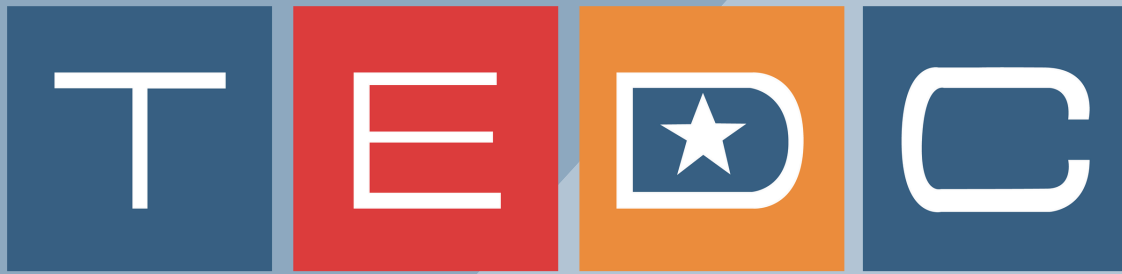

TEXAS ECONOMIC DEVELOPMENT COUNCIL

THE TEXAS ECONOMIC DEVELOPMENT COUNCIL (TEDC) IS A 501(C)(6) NON-PROFIT, PROFESSIONAL ASSOCIATION. THE ORGANIZATION IS GOVERNED BY A 30-MEMBER BOARD OF DIRECTORS AND A 9-MEMBER EXECUTIVE COMMITTEE.

The Texas Economic Development Council, founded in 1961, is an Austin-based professional association for economic developers across the state of Texas. We are the largest state association of economic development professionals, volunteers, and elected officials. Our membership consists of almost 1,100 individuals, representing nearly 650 public and private economic development organizations, including more than 400 communities. Our diverse and expansive membership shares a common goal -- bringing new investment and jobs to Texas by developing strategies that promote a positive business climate in our state.

The TEDC is dedicated to the development of economic and employment opportunities in Texas through our many programs and services such as: conferences, educational and certification programs, mentorship and leadership programs, resources, publications, advocacy, and much more.

TEDC membership is open to anyone with an interest in economic development. Most of our members are professional economic developers, community volunteers, or elected officials. A growing number represent local workforce development boards and some of our members work in fields related to economic development -- utilities, real estate, banking, education, engineering, and consulting. With two types of membership available, joining the TEDC is an excellent value.



# MEMBERSHIP TYPES AND BENEFITS

## ACTIVE MEMBERSHIP (A)

Active Membership is **\$600** per year and is for professionals who commit all or a portion of their time directly involved in economic development, or a related field.

## VOLUNTEER MEMBERSHIP (V)

Volunteer Membership is **\$170** per year and is defined as an elected or appointed individual that serves an economic development organization in an unpaid capacity.

## STATE MEMBERSHIP (S)

State Membership is **\$25** per year and is defined as an employee of an Austin-based state agency or administrative organization that receives funding from state appropriations.

# EDUCATIONAL PROGRAMS

MEMBERSHIP IN THE TEDC UNLOCKS ACCESS TO MANY ONLINE AND IN PERSON COURSES, CERTIFICATION, AND OTHER LEARNING OPPORTUNITIES.



## BASIC ECONOMIC DEVELOPMENT COURSES (BEDC)

The Texas BEDC is offered three times per year. The BEDC will provide the participant with a professional understanding of the keys of successful economic development. For those new to the profession, the BEDC is the first step toward professional certification. The BEDC is accredited by the International Economic Development Council (IEDC). As such, the TEDC is required to record attendance to meet IEDC Course Standards. Each attendee must complete the requisite number of hours for all course modules in order to receive a completion certificate for the BEDC. The BEDC qualifies as a professional economic development training requirement to sit for the Certified Economic Developer (CEcD) examination.



## CERTIFIED TEXAS ECONOMIC DEVELOPER (CTED) PROGRAM

Texas' first and only professional certification for economic development. TEDC and Texas A&M Engineering Extension Service (TEEX) have partnered to create the Certified Texas Economic Developer Certification Program. The CTED is the highest distinction of knowledge and credibility for Texas-based economic development practitioners. It is an expert-led, peer-driven certification program for active economic development professionals with curriculum tailor-made and unique to Texas. Consider becoming a Certified Texas Economic Developer to take your career to the next level and be recognized as the one of the best economic developers in Texas! Requirements for eligibility apply, must be an ACTIVE TEDC member.



## ECONOMIC DEVELOPMENT SALES TAX WORKSHOPS

Economic Development Sales Tax Workshops are designed specifically for Economic Development Corporation Board Members and local elected officials of Type A and Type B Corporations. The workshops include information about economic and community development, permissible projects under the law and any recent changes to the Economic Development Sales Tax Law. Workshop attendees will receive Open Meetings Act and Public Information Act certification as a part of this course. The ED Sales Tax Workshop is the required training under the Texas Local Government Code Section 502.101 governing Type A and Type B EDCs.



## TEDC FUTURE LEADERS TRAINING PROGRAM

This program is designed to foster future leaders in the TEDC, encourage leadership in the participant's own organization and their community. Created in 2019 with the main mission of growing leaders within the TEDC and helping them build their TEDC resume. To be eligible for this program, participants must be Active TEDC members.

This program is built around the core values of: integrity, accountability, respect, trust, authenticity, impact-oriented, servant leadership

# RESOURCES AND PUBLICATIONS

The TEDC publishes documents and reports periodically for our members. We post a legislative agenda prior to each Texas legislative session and we publish a legislative wrap-up report at the close of each legislative session. The TEDC publishes a Compensation & Benefits Survey bi-annually in even-numbered years and in odd-numbered years we publish a Member Survey. The TEDC offers resources for every position in economic development, including a job board for those looking to start or further their career in the field.

6. Support and promote Programs for Innovation and Entrepreneurship to spur Economic Growth







# ADVOCACY

The TEDC has consistently led legislative efforts to protect critical economic development programs, including: the Economic Development Sale Tax, the Texas Enterprise Fund, the Texas Economic Development Act (formerly Chapter 313 now Chapter 403) the Skills Development Fund and Enterprise Zones legislations.

The TEDC also has a Political Action Committee (PAC) which provides financial support to candidates and office holders who support a robust, competitive environment for economic development in the state.
