

# TEXAS WORKFORCE COMMISSION SKILLS FOR SMALL BUSINESS Program Overview

#### Introduction

The <u>Skills for Small Business</u> (SSB) program is an exciting opportunity for a small business to request training for its employees to support improvement of overall operations. The Texas Workforce Commission (TWC) implemented this initiative in coordination with the <u>Office of the Governor's Small Business Forums</u> in an effort to address the training needs of small businesses in Texas.

## **Eligible Applicants**

- To participate in the SSB program, a business must:
  - Be a private business;
  - Employ at least one and not more than 99 individuals total companywide;
  - Be financially stable;
  - Be liable to pay <u>Unemployment Insurance</u> contributions to TWC and be in compliance with the reporting and payment requirements; and
  - Be in compliance with the Texas Business and Commerce Code.

### **Program Information**

- The program will cover the following costs:
  - Tuition and fees costs for course offerings provided by eligible <u>public community and technical colleges</u> in the local area. (*Important Note: The SSB program will not cover costs for course offerings from third-party vendors, universities, or proprietary or vocational schools. Additionally, all funds are disbursed directly to eligible training providers for any approved training. No funds are disbursed to businesses with approved trainees)*;
  - Up to \$1,800 in a 12-month period for a new employee; and
  - Up to \$900 in a 12-month period for an existing employee.
- For the purposes of this program, a *new employee* is defined as an individual who is hired in the 12 months prior to TWC's receipt of the application requesting training. An *existing employee* is one who is currently employed by the business and has been employed for longer than the 12 months prior to TWC's receipt of the application.
- ➤ No courses are considered or funded retroactively.
- > Businesses will be responsible for all course costs not covered by SSB funding.
- ➤ It is a statutory requirement of the program that the hourly wage of each employee for whom training is being requested meets or exceeds the <u>prevailing wage</u> for that occupation in the local labor market. TWC will use <u>local labor market wage data</u> to determine if this requirement is met.





➤ Businesses must be private, for-profit entities that employ at least one and not more than 99 individuals. (Note: Business entities associated with a corporate office, multiple business entities or a corporation that exceed 99 employees are not eligible for Skills for Small Business-funded training.)

#### **Data Reporting Requirements**

If your business' application is determined to be fundable, you will be asked to please provide TWC with specific data on each participating employee before the application is approved and funds are released to the college. It will be used by the college to track each employee's progress in the approved courses and in reports to TWC. Following are the required data elements that must be provided to TWC prior to final approval on the application and release of funds to the college for the requested training:

- Employee's full name, middle initial (if applicable), and last name
- Employee's Social Security number\*
- Employee's home street address
- Employee's birth date
- Employee's veteran status (Yes or No)
- Employee's hire date

\*IMPORTANT: There is NO alternative to the use of a SSN as the identifier of individual employees participating in the Skills for Small Business program. <u>Businesses and/or employees who do not allow the release of this information to TWC will not be able to participate in the program.</u> Upon application approval, TWC staff will follow up with your business for secure receipt of required information.

### **Procedure for Submitting an Application**

Skills for Small Business offers two options for completing and submitting applications.

- **FIRST/PREFERRED OPTION:** A fully electronic version may be completed, finalized with an E-signature and submitted to TWC (Preferred submission; applications can be processed more quickly).
- SECOND OPTION (only if you do not have email capabilities): A Microsoft Word version and accompanying Attachment A spreadsheet may be submitted in lieu of the online version to <a href="mailto:SkillsForSmallBusiness@twc.state.tx.us">SkillsForSmallBusiness@twc.state.tx.us</a>. These versions require an original *signed* application to be faxed or mailed to the following:

It is recommended applications are submitted at least two weeks prior to and no more than six weeks in advance of requested training.

### **Funding Notification**

If an application is determined to be fundable, the business will be asked to provide required information on each participating employee. The college will use this information to track and report to TWC on the employee's progress throughout training. This information must be received by TWC before final approval of the application and release of funds to the college. *All SSB program funds will go directly to the college to cover the costs of the approved training. The business will be responsible for any balance due to the college.* Important Note: If an employee withdraws from an approved course before the withdrawal deadline, TWC will be refunded the amount paid by the SSB program, with any remaining balance, if applicable, going to the business.
